PROFESSIONAL CARRIER

After completing his forestry degree in 1981, Dr. Xanthopoulos served in the Greek Armed Forces and worked for a year for the Greek Forest Service before leaving in 1984 for the U.S.A. where he pursued his M.Sc. and Ph.D. degrees. Returning in Greece in 1990, he initially worked as research assistant for the Forest Research Institute of the National Agricultural Research Foundation (NAGREF) of the Ministry of Agriculture in Thessaloniki, and as assistant professor for the Forestry College in Drama, in northern Greece, in the academic year 1991-1992, teaching forestry and computer courses.

In 1992, he founded his own consulting firm "Natural Resource Technologies Consulting". Through his firm he offered specialized consulting services and participated in many European research projects, in cooperation with the Mediterranean Agronomic Institute of Chania (MAICh), the Institute of Mediterranean Forest Ecosystems and Forest Products Technology (IMFE&FPT) of NAGREF in Athens, as well as with private enterprises such as Algosystems S.A., EPSILON International S.A., and CINAR S.A. In parallel with these activities, Dr. Xanthopoulos worked for IMFE&FPT for a year (1993-1994) and then served as advisor to the General Secretary of Forests and Natural Environment of Greece (1994-1996) on forest fire related issues, having direct involvement in operational fire management. Among his main activities in that period was participation in the yearly fire management planning for Greece, development of a computer based decision support system for water bomber dispatching, participation in the organization and training of the first airborne firefighter crews, introduction of systematic forest fire investigation training to the Greek Forest Service, a leading role in the design of forest fire prevention campaigns, and preparation of a yearly analysis the results of each fire season in a report that also included proposals for correction of existing problems and better future organization. Of special importance was the introduction, in 1996, of a daily fire danger prediction map for the first time in Greece, to be used as basis for presuppression planning for the country. He prepared this map through the 1996 and 1997 fire seasons.

In 1998 responsibility for forest firefighting was transferred to the Greek Fire Service which belonged to the Ministry of Public Order. In winter 1999 Dr. Xanthopoulos was asked to serve as advisor to the Minister of Public Order on forest fires related issues. From that position he offered planning advice and training to Fire Service officers and was also responsible for the daily preparation of the fire danger prediction map for the country for the summers of 1999, 2000 and 2001. He continued his direct involvement in this task until 2004. In parallel, from February 2001 till September 2002 he also served in a committee advising the General Secretary for Civil Protection in Greece.

In December 2001, Dr. Xanthopoulos resigned from his position at the Ministry of Public Order to accept a researcher position with the Institute of Mediterranean Forest Ecosystems & Forest Products Technology (IMFE&FPT) of the National Agricultural Research Foundation (NAGREF), in Athens. Currently, he is in charge of forest fire research at the Institute having participated in a significant number of fire related research projects while at the same time offering, upon request, support to the Greek operational organizations which are engaged in

forest fire prevention, suppression and post-fire mitigation. Since late 2011, the Institute belongs to the Hellenic Agricultural Organization "Demeter", a new public organization created from merging four organizations of the Ministry of Rural Development and Food, one of which was NAGREF. The name of the Institute was also shortened and became "Institute of Mediterranean Forest Ecosystems" (IMFE).

The research work of Dr. Xanthopoulos is substantial and is reflected in the table of research projects he has been involved with (shown below), being scientific responsible and manager for many of them, as well as in the long list of publications attached to this CV. Furthermore, Dr. Xanthopoulos participates in the post-graduate programs on Natural Disasters Management of the Department of Geography of the Harokopio University of Athens. As part of this involvement he offers lectures on forest fire management and serves as main advisor or committee member for the M.Sc. Theses and Ph.D. Dissertations of many graduate students.

At international level, from 1990 Dr. Xanthopoulos has offered his services to the European Commission numerous times, either as reviewer of scientific research proposals or by participating in policy development meetings. He has also participated in similar consultations for the Food and Agriculture Administration (FAO), has been a member of the UNECE/FAO Team of Specialists on Forest Fires, and is currently a member of the UNISDR Wildland Fire Advisory Group. He has participated in numerous international conferences, often as invited speaker.

Dr. Xanthopoulos has served as an associate editor for the "International Journal of Wildland Fire" for more than two decades and has also offered his services as a reviewer for this and many other scientific journals. He has served as member of the Board of Directors of the International Association of Wildland Fire for two 6-year terms, and is also a member of the Geotechnical Chamber of Greece, and the Hellenic Forestry Association.

The research interests of Dr. Xanthopoulos include forest fire policy, fire prevention, forest fuel management, fire behaviour modelling, fire danger rating, forest firefighting and firefighter safety, and modern technologies application in forest fire management. He strongly promotes the concept of Integrated Forest Fire Management. His long track record in forest fire research in combination with his involvement with operational fire management have allowed him to build an in-depth understanding and balanced views on fire management policy issues. His emphasis is on work that can directly benefit the operational world of forest fire management, with which he maintains good links.
